7.5 Governing Law, Dispute Resolution. The parties agree to submit to the exclusive jurisdiction of the state and federal courts located in Riverside County any and all disputes not resolved within 30 days of notice. Notice to Inside Tract shall only be proper if made by certified mail at the address provided herein.

7.6 Equitable Relief. You agree that your breach of these Terms of Use may cause irreparable damage and that, in the event of such breach, in addition to any and all remedies at law, Inside Tract shall have the right to seek an injunction, specific performance, or other equitable relief in any court of competent jurisdiction without the requirement of posting a bond or undertaking or proving injury as a condition for relief.
